

### **Visiting New Zealand**

The following documents must be forwarded to the Consulate General in Los Angeles for processing:

- ( ) Completed visitor's visa application signed and dated by applicant.
- ( ) A recent passport size photograph with applicants name printed on the back of it.
- ( ) Passport (**must be valid three months beyond the intended date of departure from New Zealand**)
- ( ) **Visitor's visa application fee schedule:**
  - **No visitor's visa fee is required for holders of the following passports: Austria, Finland, Greece, Iceland, Israel, Italy, Japan, Mexico, Russia, Turkey and USA.**  
*(Phillipines - for visits not exceeding 59 days the visitor's visa fee is not applicable)*
  - An application fee of US\$75.00 is required for holders of the following passports: Fiji, Kiribati, Marshall Islands, Micronesia Federation, Palau, Papua New, Guinea, Samoa, Solomon Islands, Tonga, and Vanuatu.
  - **An application fee of US\$95.00 is required for all other passport holders.**

**AS WE DO NOT HAVE CREDIT CARD FACILITIES, ALL VISA FEE PAYMENTS MUST BE BY MONEY ORDER OR BANK CASHIERS CHEQUE ONLY.**

- ( ) Evidence of funds. This can be in the form of travellers' cheques, bank draft, letter of credit from a bank, a recent bank statement or credit card statement of the following credit cards showing available credit.
- ( ) Flight itinerary from travel agent or carrier confirming your travel arrangements to a country to which you have right of entry.
- ( ) **Non United States Citizens: If returning to the U.S applicants must produce evidence of their right of entry, i.e. either a valid visa or a copy of both sides of their alien registration card.**

**IMPORTANT NOTES:**

- All applications must be accompanied by a self-addressed, prepaid courier (For example, Federal Express or UPS) airway bill for the safe return of your passport and original documents.
- Incomplete visa applications will be returned to you.
- The New Zealand Consulate-General is NOT responsible for any documents or passports lost in transit.
- Please allow up to 10 working days for your visitor visa to be processed. If, however, we are unable to determine whether or not you are in good health, our processing time may take up to 2 to 3 months.
